Jeff Waldron reported there are two cases of swine flu in North Jersey, Sussex County. With the various illnesses, now including Zika, it is the responsibility of individuals to protect themselves against exposure by using insect repellents containing Deet.

The Zika virus information is constantly being updated as the testing goes on for the various ways it is contacted, transmitted and the birth defects that can occur to babies born to pregnant women with the virus.

Tony Szumski received a letter from Steve Foster of the Musconetcong Watershed. (Tom Scheibener will pass this on to the Environmental Committee.)

Donna Lizanich reported that on January 22 she attended a webinar presented by the NJ Department of Health on NJ Emergency Support Function 8 (ESF-8) — Public Health and Medical Services. The webinar described the organizational structure, purpose and operational activities of ESF 8. The ESF 8 plan is being updated to improve access for the functional needs population so that their issues can be better addressed. The next webinar, tentatively scheduled for February 22, will be on Medical Needs Shelters.

Jeff Waldron suggested a questionnaire be sent to residents on a yearly basis to respond if they need special help during an emergency situation or power failure.

Donna stated the OEM has a list of the residents needing help. Tom Scheibener stated the Holland police also have this list of residents, as does the Office on Aging in the township. This information is not for publication.

Tom Scheibener will not be attending the March Board of Health meeting.

Christopher Balogh made a motion to adjourn the meeting, seconded by Tom Scheibener. The meeting adjourned at 8:07 P.M.
