-ORDINANCE 2015-9-Public Hearing/Final Adoption--Creating Sergeant position Mr. Roselle moved and Mr. Bush seconded the motion to adopt Ordinance 2015-9 on Final Reading **ORDINANCE 2015-9**

CREATING THE POLICE DEPARTMENT POSITION OF SERGEANT

WHEREAS, it is the desire of the Township Committee of the Township of Holland, County of Hunterdon, State of New Jersey (hereinafter referred to as the "Township Committee"), to create and establish the position of Sergeant within the Department of Police and Public safety of the Township of Holland ("Police Department"); and

WHEREAS, pursuant to <u>N.J.S.A.</u> 40A:14-118, the governing body of any municipality, by Ordinance, may provide for the appointment of such members of the police department, including the prescription of their powers, functions and duties, as shall be deemed necessary for the effective government of such police force; and

WHEREAS, pursuant to Chapter 32 of the Holland Township Code, the Township Committee created a Police Department and lawfully reserved unto itself the power to create other such members and officers of the Police Department as it shall deem necessary; and

WHEREAS, the Township Committee deems it necessary to create and establish the position of Sergeant of the Police Department.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Committee of the Township of Holland, in the County of Hunterdon and State of New Jersey, that the following provisions of the Code of the Township of Holland are amended as follows:

SECTION 1. Section 32-2 of the Code of the Township of Holland entitled "Composition" is hereby amended and supplemented as follows (Additions indicated in boldface and italics *thus*; deletions indicated with strike-through thus):

Said Department shall consist of a Chief of Police and *may consist of* such number of *Sergeants and* policemen as may be determined, from time to time, by the Township Committee.

SECTION 2. Section 32-3 of the Code of the Township of Holland entitled "Designation of Township Committee as Appropriate Authority" is hereby amended and supplemented as follows (Additions indicated in boldface and italics *thus*; deletions indicated with strike-through thus):

The governing body of the Department, which is also the appropriate authority as referred to in N.J.S.A. 40A:14-118, is the Township Committee. The Township Committee shall exercise the responsibilities of an appropriate authority under New Jersey Statutes, and in particular shall be responsible for the promulgation of rules and regulations for the government of the Department and for the discipline of its members. The Mayor of the Township shall be in general charge of the Department, and, in his absence, the Deputy Mayor shall assume this responsibility. The line of authority relating to the police function of this Township shall be from *the Sergeant (if any) to* the Chief of Police, *as the head of the Police Department*, to the Mayor (or Deputy Mayor, in the Mayor's absence) to the Township Committee.

If the office of Sergeant is intentionally left vacant, it will be deemed not to exist and will be bypassed in the chain of command (e.g., if the governing body chose not to appoint a Sergeant, then all civilian employees and policemen would answer directly to the Chief of Police).

SECTION 3. Section 32-14 of the Code of the Township of Holland entitled "Duties and Responsibilities of Sergeant" is hereby added as follows:

The position of Sergeant shall be second in command to the Chief of Police. The Sergeants' powers, functions and duties shall be as follows:

- A. He or she shall, during his or her regular tour of duty, be superior in rank to and have charge of all policemen and special police officers who shall be serving on the same shift and shall, generally, supervise the work of all said members and shall give such instructions and directions as he or she shall deem necessary for the proper and efficient operation of the Department in accordance with the provisions and regulations of this chapter.
- B. He or she shall designate the streets, avenues and areas of the Township to be patrolled by such members of the Department as shall have been assigned to patrol duty on his or her shift.
- C. He or she shall see that officers reporting to him or her properly relieve the officers going off duty and that the officers are in proper uniform, with the necessary equipment to perform their duties properly.
- D. He or she shall assign all policemen to their respective duties and shall note whether or not the officers to be relieved are at their given relieving point and in proper condition.
- E. He or she shall constantly patrol his or her assigned area and shall supervise the work of the officers in patrol cars and performing any other type of duty.

- F. He or she shall review for approval all written reports made by the officers under his or her supervision during a tour of duty. If reports fail to meet with his or her approval, he or she shall instruct the officers under his or her supervision as to the proper form and information to be supplied.
- G. He or she shall perform his or her duties under the supervision and direction of the Chief of Police and shall be responsible for seeing that all laws of the State of New Jersey and ordinances of the Township of Holland are duly observed and enforced and that the public peace is maintained. The Sergeant shall perform such duties as may be assigned to them, from time to time, by the Chief of Police.
- H. He or she shall, during his or her regular tour of duty, in addition to the performance of the duties of Sergeant specified herein, exercise the authority and perform the duties of a police Officer as far as practicable.

SECTION 4. All Ordinances or parts of Ordinances inconsistent herewith are repealed as to such inconsistencies.

SECTION 5. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

SECTION 6. This Ordinance shall take effect upon final passage and publication according to law.

-Discussion-email received from Hunterdon County Roads Dept containing a request from Holland Township resident Rob Castagna to consider "no parking" signs on Route 627 near Spring Garden Road

Mr. Castanga wrote:

-Route 627 north of Milford close to Spring Garden Road in Holland Twp: There has been a rope swing there along the river for several years and the road, commonly known as the narrows, has become a parking lot for numerous vehicles so that fun seekers can access the river and swing. As you may know, this is a one lane road that has many spots impossible for two cars to pass. During the summer weekends it is not unusual to find 15-20 cars parked along this road. With cars parked along the road it makes it impassable for large trucks as well as dangerous for anyone else due to the narrow space and congestion of people walking along the road and carrying their coolers.

At the July 16, 2013 meeting the Committee discussed a letter from the Belvidere & Delaware River Railway requesting support for signage such as "No Stopping or Standing" along the right-of-way from the Milford Borough line north approximately 3 miles through the Delaware River narrows in Holland Township
