ORDINANCE 2013-11

BOND ORDINANCE, AMENDING ORDINANCE 2007-22, ORDINANCE 2009-20, AND ORDINANCE 2010-21 TO PROVIDE FOR CAPITAL IMPROVEMENTS TO VARIOUS PUBLIC ROADS OF THE TOWNSHIP, BY AND IN THE TOWNSHIP OF HOLLAND, IN THE COUNTY OF HUNTERDON, NEW JERSEY, APPROPRIATING \$1,170,000 THEREFOR, AND AUTHORIZING THE ISSUANCE OF \$889,507.82 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF

WHEREAS, this Township Committee previously adopted a bond ordinance, being Ordinance No. 2007-22 which was entitled "Bond Ordinance Providing For A Capital Improvement To Crabapple Hill Road, By And In The Township Of Holland, In The County Of Hunterdon, New Jersey, Appropriating \$875,000 Therefor, And Authorizing The Issuance Of \$825,000 Bonds Or Notes Of The Township To Finance Part Of The Cost Thereof," and said Ordinance No. 2007-22 is still in full force and effect; and

WHEREAS, this Township Committee previously adopted a bond ordinance, being Ordinance No. 2009-20 which was entitled "Bond Ordinance, Amending Ordinance 2007-22, To Provide For Capital Improvements to Various Public Roads of the Township by and in the Township of Holland, in the County of Hunterdon, New Jersey, Appropriating \$1,100,000 Therefor, and Authorizing the Issuance of \$1,045,000 Bonds or Notes of the Township to Finance Part of the Cost Thereof," and said Ordinance No. 2009-20 is still in full force and effect; and

WHEREAS, this Township Committee previously adopted a bond ordinance, being Ordinance No. 2010-21 which was entitled "Bond Ordinance, Amending Ordinance 2007-22, To Provide For Capital Improvements to Various Public Roads of the Township by and in the Township of Holland, in the County of Hunterdon, New Jersey, Appropriating \$1,100,000 Therefor, and Authorizing the Issuance

of \$1,045,000 Bonds or Notes of the Township to Finance Part of the Cost Thereof," and said Ordinance No. 2010-21 is still in full force and effect; and

WHEREAS, this Township Committee determined a need to alter its program for improvement of public roads of the Township, to include capital improvement to all or portions of the following public roads of the Township: Adamic Hill Road, Alfalfa Hill Road, Church Road, and Crabapple Hill Road, and there is a need to provide financing for such program of capital improvement and so to amend Ordinance No. 2007-22, Ordinance No. 2009-20 and Ordinance 2010-21 and restate them in a new bond ordinance which provides for such financing;

BE IT ORDAINED, by the Township Committee of the Township of Holland, in the County of Hunterdon, State of New Jersey (not less than two-thirds of all members thereof affirmatively concurring, and as an amendment and restatement of Ordinance No. 2007-22, Ordinance No. 2009-20 and Ordinance No. 2010-21) as follows:

Section 1:

The improvement described in Section 3 of this bond ordinance is hereby authorized to be undertaken by the Township of Holland, in the County of Hunterdon, New Jersey, as a general improvement. For the improvement or purpose described in Section 3, there is hereby appropriated the sum of \$1,170,000, including the sum of \$125,000 as the down payment required by the Local Bond Law [N.J.S.A. 40A:2-1 et seq.]. The down payment is now available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets, and the sum of \$155,492.18 from the General Capital Fund Balance

Section 2:

In order to finance the cost of the improvement or purpose not covered by application of the down payment, negotiable bonds are hereby authorized to be issued in the principal amount of \$889,507.82 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes in a principal amount not exceeding \$889,507.82 are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3:

(a) The improvement hereby authorized and the purpose for the financing of which the bonds are to be issued is pavement and other improvements to various existing public roads of the Township [including Adamic Hill Road, Alfalfa Hill Road, Church Road, and Crabapple Hill Road], including all costs necessary therefor or incidental thereto.

(b) The estimated maximum amount of bonds or notes to be issued for the improvement or purpose is as stated in Section 2 hereof.

(c) The estimated cost of the improvement or purpose is equal to the amount of the appropriation herein made therefor.

Section 4:

All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no note shall mature later than one year from its date, or as otherwise authorized by the Local Bond Law. The notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with notes issued pursuant to this ordinance, and the chief financial officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. Chief financial officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

Section 5:

The capital budget of the Township of Holland is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by

the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 6:

The following additional matters are hereby determined, declared, recited and stated:

(a) The improvement or purpose described in Section 3 of this bond ordinance is not a current expense. It is an improvement or purpose that the Township may lawfully undertake as a general improvement, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.

(b) The period of usefulness of the improvement or purpose within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this ordinance, is 5 years.

(c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$889,507.82, and the obligations authorized herein will be within all debt limitations prescribed by that Law.

(d) An aggregate amount not exceeding \$75,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purpose or improvement.

Section 7:

Any grant moneys received for the purpose described in Section 3 hereof shall be applied either to direct payment of the cost of the improvement or to payment of the obligations issued pursuant to this ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 8:

The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy ad valorem taxes upon all the taxable real property within the Township for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 9

This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

Statement from the Chief Financial Officer

The above Amending Ordinance was discussed at the meeting with the Township Auditor. The need for this amending ordinance is the result of certain change order required at the time the work was completed. It was expected that additional funding would be received from the Delaware River Joint Bridge, however the funds were not available from the Authority thereby requiring this additional amendment to the Ordinance.

Mayor Bush opened the Public Hearing and asked if there were any comments from the public. There being no comments from the public, the hearing was ordered closed

NEW BUSINESS REGARDING BETHANY RIDGE

Press Release-The consensus was Clerk Miller should publish the following press release:

TOWNSHIP OF HOLLAND, HUNTERDON COUNTY, NEW JERSEY. Mayor Dan Bush announced the purchase of the 158-acre Bethany Ridge tract formerly owned by the Diocese of Metuchen. The site, located just to the east of the Township's Riegel Ridge Recreational Center, was purchased for \$1.2 million dollars. The County of Hunterdon has committed \$600,000 to the purchase price and the Township is optimistic that its partner, Hunterdon Land Trust, will secure a grant from the County for over \$200,000 toward the purchase. The Victoria Foundation, a private entity that provides help with the acquisition of public land, is also considering a contribution. The Township has already received a \$40,000 grant from the Hunterdon County Open Space Fund to help with the purchase.

Consisting of two tracts, one with a house and about 40 acres, and a second with 117 undeveloped acres, Bethany Ridge is one of the prime properties in western Hunterdon County. The land has gentle to moderate slopes in the westerly section and steeply sloping and heavily wooded areas in the east. The property is bisected by two tributaries of the Hakihokake Creek. It has about 48 acres in tilled fields.

Much of the property to its east and south is already open space. To the southeast is the Oak Hill Golf Course and directly to the east are several parcels owned by the County of Hunterdon.

Located on the property is a circa 1929, eight bedroom residence built by the Riegel Paper Company as an executive retreat. It is an extremely handsome, natural stone home of approximately 7,000 square feet. The interior was artfully constructed with raised paneled molding, painted plaster walls and ceilings, a large masonry fireplace, decorative box beam ceilings and distressed oak flooring with cup head nails. A three-car garage was converted by the Diocese into a chapel. The house is in good condition, having been well cared for by the Diocese and there are two cottages adjacent to the house.

Mayor Bush expressed considerable excitement over the purchase: "This property is a great acquisition for the Township. With the property being connected to the sewer line and having almost 50 acres of farm fields, it would have been a prime target for developers. Now, it can be used for the many recreational needs of Holland Township residents."

Deputy Mayor Tony Roselle, a prime mover in the acquisition, said: "The Diocese was great to work with. The Bishop had a clear-eyed view of how to work out a deal that was beneficial to both parties. After tough negotiations, the Diocese lived up to every promise it made, and then some."

Ken Vogel, a committeeman who believes in fiscal responsibility and maintains a cautious approach to acquiring property, said he supported this project, was pleased with the acquisition and the fact that outside agencies would be making substantial contributions to the Township's return on investments.

Committeeman Tom Scheibener, who was part of the negotiating team, emphasized the value of this tract from a recreational standpoint. He said: "We are beginning work on a Master Plan for this property. We see a lot of potential to fill in the recreational gaps. For example, this property would be a great site for additional soccer fields. Right now, there is a real shortage in that area and this

property, located adjacent to Riegel Ridge and all of its facilities, will create a fantastic opportunity for the Township to provide recreational opportunities for the Township for the next 50 years or more."

Committeeman Ray Krov, a business administrator for a large school system, pointed out that the Township expects to close on another 13 acres owned by the Diocese adjacent to the Bethany Ridge tract. He said: "What I like about this deal is we got a great price per acre, we got a lovely house thrown in, and now we are getting 13 more acres from the Diocese at no additional cost. The Diocese has been a great partner."

Mayor Bush also expressed appreciation to the Diocese for all of its cooperation, fair dealings and help. He also thanked the Township partners in the deal: the County of Hunterdon and Hunterdon Land Trust. "The Freeholders really came to bat for us. Freeholder Director Walton was a big proponent of this project from the beginning and provided invaluable help. The Township taxpayers should be very grateful to Freeholder Director Walton and the other Freeholders for their selfless support."

Mayor Bush went onto say that he could not say enough good things about the Hunterdon Land Trust. He explained that Hunterdon Land Trust is a local organization that helps raise funds for and provides technical advice to municipalities about acquiring open space. He said: "HLT's Kate Buttolph was there for us from the beginning. She worked tirelessly to guide us and help us through the process." Mayor Bush continued: "I just hope that the County and Hunterdon Land Trust can work out the additional contribution the Township is looking for. The more money we can get from our partners, the more open space and recreational land we can acquire for the public."

When asked what the Township would do with the lovely stone executive mansion on the site, Mayor Bush said: "We don't know yet. The answer to that question will depend on public input and the recreational study being headed up by Committeemen Scheibener and Roselle. It could be sold as a lovely private residence or it could have a public use; we'll have to see."
