May 13, 2021

On Thursday, May 13, 2021, at 7:35 P.M., the regularly scheduled meeting of the Holland Township Board of Health was held in the meeting room at the Municipal Building, Church Road.

The above correspondence was discussed and action taken as necessary.

Pearl reported she received a copy of a well casing report on Marc Phillips, Block: 13 Lot: 8, showing 51 feet of 6" casing. Since there is enough casing in the well, the UV treatment is not necessary on this Waiver letter. Pearl contacted the County Health Department and sent them a copy of the report.

Donna Lizanich reported on the Covid-19 vaccinations given at Riegel Ridge. Appointments were handled through the Holland Pharmacy. Nine people were vaccinated on April 18, fifty people vaccinated on April 25, and not enough people signed up for May 2, so residents had to go back to the Holland Pharmacy to receive their injections.

Pearl had spoken to the Maria Elena regarding Mrs. Stangil's concern about water draining from her neighbor's property onto her yard. Mrs. Stangil will watch the situation before making a formal complaint to the Zoning Officer. This is not a Board of Health issue, since the new septic system was approved by the County Board of Health and completed properly.

Audrey stated she has been tracking the daily Coronavirus statistics by State, County and Holland Township.

Christopher Balogh made a motion to adjourn the meeting, seconded by Donna Lizanich. The meeting adjourned at 8:00 P.M.
