

BOARD OF HEALTH
November 11, 2021

On Thursday, November 11, 2021, at 7:31 P.M., the regularly scheduled meeting of the Holland Township Board of Health was held in the meeting room at the Municipal Building, Church Road.

Before the meeting was opened, the Pledge of Allegiance was recited.

The meeting was called to order by Chairperson, Audrey Balogh, and the following statement was read at the commencement of the meeting.

Adequate notice of this regular meeting was given pursuant to the Open Public Meetings Act, by the Township Clerk on December 10, 2020, by:

1. Posting such notice on the bulletin board at the Municipal Building and on the Holland Township website.
2. Mailing the same to the Hunterdon County Democrat and the Express Times.

Members present at the meeting: Pearl Hammerstone, Audrey Balogh, Christopher Balogh, Donna Lizanich, and Tony Szumski

Members Absent: Lisa Mickey, Karen Young and Vann Smith

Also in attendance: Charles Tiedeman, PE, Finelli Consulting Engineers, Lenny Boutros and Kurt Hoffman, P.E.

Donna Lizanich made a motion, seconded by Christopher Balogh, to accept the minutes of October 14, 2021. Motion carried.

Septic System Alteration Waiver – Block: 5 Lot: 28, 494 Bellis Road, Milford, NJ. Charles Tiedman is requesting a Waiver to correct a malfunctioning system with no expansion. The design is in full conformance with 7:9A, “Standards for Individual Subsurface Sewage Disposal Systems”, except for the waiver requested.

1. The proposed disposal bed will be only 85 feet from the existing well which does not meet the minimum set back requirement of 100 feet. The distance can be reduced to 50 feet if there is 50 feet of casing in the well. A well report by Colaluce Well dated July 14, 2021 states there is only 20 feet of casing. The County is recommending the engineer install an ultra violet treatment on the well for added protection and a passing water test for coliform be obtained after treatment.

After discussion, Christopher Balogh made a motion to grant the waiver for Block: 5 Lot: 28 for the distance of the proposed disposal bed being only 85 feet from the existing well. A passing coliform test from a NJ certified lab must be provided to the County Health Department once the UV light is installed. Tony Szumski seconded the motion. A roll call vote was taken. Pearl Hammerstone, aye; Audrey Balogh, aye; Christopher Balogh, aye; Tony Szumski, aye; Donna Lizanich, aye. It was a unanimous *aye* vote to grant this waiver.

Septic System Alteration Waiver – Block: 5 Lot: 73, 420 Bellis Road. Kurt Hoffman is requesting a Waiver to correct a malfunctioning system with no expansion. The design is in full conformance with 7:9A, “Standards for Individual Subsurface Sewage Disposal Systems”, except for the waiver requested.

The Proposed disposal bed will be only 68 feet from the existing well which does not meet the minimum set back requirement of 100 feet. The distance can be reduced to 50 feet if there is 50 feet of casing in the well. Due to the age of the well the engineer has proposed an Ultra Violet treatment device for added protection. A water test for coliform shall be done to ensure the device is working.

After discussion, Tony Szumski made a motion to grant the waiver for Block: 5 Lot: 73 for the distance of the proposed disposal bed being only 68 feet from the existing well. A passing coliform test from a NJ certified lab must be provided to the County Health Department once the UV light is installed. Christopher Balogh seconded the motion. A roll call vote was taken. Pearl Hammerstone, aye; Audrey Balogh, aye; Christopher Balogh, aye; Tony Szumski, aye; Donna Lizanich, aye. It was a unanimous *aye* vote to grant this waiver.

Memo to Steven Moninghoff, Re: Individual Sewage Disposal System Block: 19.01 Lot: 6, 31 Old River Road.
Failure of owner of the advanced wastewater treatment septic system (Eco-Flo Peat Bio filter) to maintain a service contract throughout the life of the system.
(The Board of Health granted a Waiver to Wayne Ingram, Engineer in 2014. This was a ATU System Bio Kenetic, 2 tanks. For the life of the system, resident must maintain a contract with a provider to inspect every year.)
The Contractor Provider notified the County Health Department that the resident wasn't having the system checked.
