• Library/DPW Roof Recovery Project done, inspection was done this week, final accounting in progress-well done

- RRCC Roof Repairs-out to bid opened this Friday at 11:00am including lightening protection system
- Church Road Improvement Project-early August-milling and paving then oil and chip (2-3 days) Work will also be done on Mt. Joy Road
- Sewer cleaning project to start next week. 20 calendar days. School will be notified and the work will begin at the school
- Pool Repair Project- one last invoice to be authorized tonight
- Purchase of 490 Shire Rd field work is done report next week
- Spring Garden Road-We will do work in the fall-through co-op. if prices don't fall, we will be holding until winter and get work done early spring
- Road openings ordinance should be updated. There should be more requirements for the construction company. Attorney Matt Lyons and Deputy Mayor Scott Wilhelm will work with Engineer Sterbenz on an update to the Road Opening Ordinance
- Grant for Old River Road was filed

Mayor Bush advised the public that:

- Spring Garden Road and Mt. Joy Road are fully funded by state grants

Engineer Sterbenz continued with his report on issues on Bellis Road:

- 2) On street parking-the particular location there are only 2 travel lanes, no parking lane causing cars to swing wide to continue travel-Recommend amending current parking restriction to Shire Road
- DEP reassignment of Holland from Tier B to Tier A under the New Jersey Pollutant Discharge Elimination System (NJPDES) and Municipal Separate Storm Sewer System (MS4) stormwater permitting program-

There is a process that the Township could implement by July 31 to ask for a stay in this change. The consensus was the Township Committee will adopt a Resolution requesting a hearing under NEW BUSINESS tonight.

Mayor Bush advised he would like to set up a meeting with Engineer Sterbenz, himself, Committeeman Thurgarland, Environmental Commission Secretary Kozak and Chairman Keady, and Land Use Board Chairman Miller to have a conversation on how the Township will tackle this change.
