-ORDINANCE 2022-20 to Amend Parking Ordinance Chapter 170 Public Hearing October 18, 2022

ORDINANCE 2022-20

AMENDING CHAPTER 170 ENTITLED "VEHICLES AND TRAFFIC," SECTION 3 – VIOLATIONS AND PENALTIES – OF THE MUNICIPAL CODE OF THE TOWNSHIP OF HOLLAND, COUNTY OF HUNTERDON, STATE OF NEW JERSEY

WHEREAS, the Township of Holland is desirous to update and revise its Municipal Code pertaining to Chapter 170 "Vehicles and Traffic," Article I "General Provisions," Section 3, "Violations and penalties;" and

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Committee of the Township of Holland, in the County of Hunterdon, that the Municipal Code of the Township of Holland pertaining to Chapter 170 "Vehicles and Traffic," Article I "General Provisions," Section 3, "Violations and penalties," is hereby amended as follows (additions indicated in boldface and italics *thus*; deletions indicated with strike-through *thus*):

SECTION 1

§170-3. Unless another penalty is expressly provided by New Jersey statute, every person convicted of a violation of a provision of this chapter or any supplement thereto shall be liable to a penalty of not more than \$50 or imprisonment for a term not exceeding 15 days, or both upon a conviction of a violation of a provision of this Chapter, the Court shall impose a fine of no less than \$150.00 and no more than \$350.00 and, in addition, may impose a term of imprisonment not to exceed fifteen (15) days.

SECTION 2. In the event that any portion of this Ordinance is found to be invalid for any reason by any court of competent jurisdiction, such judgment shall be limited in its effect only to that portion of the Ordinance actually adjudged to be invalid, and the remaining portions of this Ordinance shall be deemed severable therefrom and shall not be affected.

SECTION 3. All ordinances or parts of ordinances deemed to be inconsistent with this ordinance are hereby repealed.

<u>SECTION 4.</u> This ordinance shall become effectively immediately upon final adoption and publication in accordance with the laws of the State of New Jersey.
