ORDINANCE 2022-20

AMENDING CHAPTER 170 ENTITLED "VEHICLES AND TRAFFIC," SECTION 3 – VIOLATIONS AND PENALTIES – OF THE MUNICIPAL CODE OF THE TOWNSHIP OF HOLLAND, COUNTY OF HUNTERDON, STATE OF NEW JERSEY

WHEREAS, the Township of Holland is desirous to update and revise its Municipal Code pertaining to Chapter 170 "Vehicles and Traffic," Article I "General Provisions," Section 3, "Violations and penalties;" and

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Committee of the Township of Holland, in the County of Hunterdon, that the Municipal Code of the Township of Holland pertaining to Chapter 170 "Vehicles and Traffic," Article I "General Provisions," Section 3, "Violations and penalties," is hereby amended as follows (additions indicated in boldface and italics *thus*; deletions indicated with strike-through thus):

SECTION 1

§170-3. Unless another penalty is expressly provided by New Jersey statute, every person convicted of a violation of a provision of this chapter or any supplement thereto shall be liable to a penalty of not more than \$50 or imprisonment for a term not exceeding 15 days, or both upon a conviction of a violation of a provision of this Chapter, the Court shall impose a fine of no less than \$150.00 and no more than \$350.00 and, in addition, may impose a term of imprisonment not to exceed fifteen (15) days.

SECTION 2. In the event that any portion of this Ordinance is found to be invalid for any reason by any court of competent jurisdiction, such judgment shall be limited in its effect only to that portion of the Ordinance actually adjudged to be invalid, and the remaining portions of this Ordinance shall be deemed severable therefrom and shall not be affected.

<u>SECTION 3.</u> All ordinances or parts of ordinances deemed to be inconsistent with this ordinance are hereby repealed.

<u>SECTION 4.</u> This ordinance shall become effectively immediately upon final adoption and publication in accordance with the laws of the State of New Jersey.

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to <u>N.J.A.C. 5:30-6.5</u>; and,

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of <u>R.S.</u> <u>52:27BB-52</u>, to wit: <u>R.S. 52:27BB-52</u>: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

Authorize the Chief Finance Officer of Holland Township to Utilize Interfund Loans Until Funds are Received from Grantor Agencies

WHEREAS, proceeds from grant agreements are contingent on actual amounts expensed after approval by grantor agencies in some instances, and

WHEREAS, the approval process may be contingent on factors that could delay the timely receipt of grant proceeds, and

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee, of the Township of Holland, County of Hunterdon on the state of New Jersey that they hereby authorize the Chief Finance Officer of the Township to utilize interfund loans until funds are received from grantor agencies.
